Some things to think about

- a. **Club Prizes:** Are there better alternatives to the present system - \$4 to each winner for any competition regardless of number of sessions, championship or not, trophy or not, handicapped or not, Teams, Pairs or Individual. – No decision made.
- b. **Regional Tournament:** We could apply to run (and we would probably be successful) a Junior/Intermediate Tournament at our Club. Are we interested? - No – not interested
- c. **We are primarily a Social Club** – most members are more interested having a Social Game with friends and acquaintances than they are in climbing the NZ Bridge ladder. Are we doing enough to make our Club attractive to those people as well as the people who haven't joined yet?
- d. **Fund-Raising Events:** We would need a good cause – Suggestions??

- e. **Club Volunteers:** We are very lucky that we have many volunteers who help manage our Club – our Club could not run without them. There are others who could possibly do more. How can we encourage them? No Suggestions

- f. **Insurance.** We pay State Insurance for **Business Liability cover** (as required under the terms of our lease) of \$2,000,000 costing \$287.50 this year, and **Contents Cover** for \$40,000 currently \$523.60.
We will ask Louise's advice on the suitability of our current level of cover

Building Cover is provided and paid for by TCDC. We have not been asked for any reimbursement.

We have been approached by PIC Insurance Brokers, who will be giving us a quote for alternative cover.
